Symptom

Customer needs implementation information regarding QuantityWare products.

Cause

Documentation overview necessary.

Solution

QuantityWare products are based on a modular design, thus it makes sense to organise the technical product documentation in the same manner. All BCS (Bulk Calculations Solution) documentation for the latest release, BCS 3.0, can be downloaded from the QuantityWare web site <https://www.quantityware.com/support/knowledge-base/>. Documentation for older releases is available on request.

When Implementing QuantityWare products, the following two major steps are necessary:

1. TECHNICALLY INSTALL THE PRODUCT

Aim: The functionality exists in the target system. One document is available for QuantityWare products.

- Technical Installation Guide

This documentation is designed for use by the basis people physically installing the product on the target system. There is only one version of this document per SAP release (ECC600 / S/4HANA) as all products (BCP, BCG, CTP, CTG) are installed via one procedure and technical delivery.

In addition to the Technical Installation Guide, notes which provide details to the technical installation are issued with note category "Technical Installation".

2. CONFIGURE AND USE THE PRODUCT

Aim: The functionality is made available to, and used by, the application. This documentation is designed for use by the Applications / Integrations / GRC staff who are responsible for designing / configuring / monitoring your solution.

Five documents are available for QuantityWare products BCP and BCG:

- Supported Standards Manual –
Detailing all supported measurement standards and their versions.
- PAIG (Project Assessment and Implementation Guidelines) –
A methodology containing high-level descriptions of the implementation steps and considerations valid during implementation and renovation projects.
- Documentation Reference Manual -
This document contains an overview of all functional and configuration options for your BCS solution.
- Test Manual -
This document provides a step-by-step description how to copy and configure a QuantityWare template conversion group for productive usage
- Customer Remote Support Manual -
Provides a detailed instruction how to provide a conversion group transport for expert analysis

QuantityWare products CTP and CTG do not require a dedicated Test Manual and Customer Remote Support Manual. In addition to the five documents listed above, notes, which detail the functional extend of BCS products, can be issued with note category "Documentation". All changes to documentation extent and relevance will be detailed in this note.
