The Current Situation

- SAP Oil & Gas comes with an open interface **SAP QCI (Quantity Conversion Interface).**
- SAP **does not** deliver any validated, measurement standards-based conversion implementation.
- Owing to complexity and risk, measurement standard-based conversion implementation **has always been a customer task.**
- Between 1990 and 2005, business process orchestration was in focus the entire topic of quantity value data flow has been neglected.



Why a Dedicated Quantity Conversion Solution?

- A dedicated quantity conversion solution for your SAP system using the SAP Oil & Gas must be plugged into the SAP QCI, **or business processes will not work:**
 - Thousands of internal SAP QCI calculations are required for daily business process
 execution a quantity conversion solution is essential.
 - Such SAP QCI calculations are also responsible for the control and enrichment of **thousands of external measurement data sets processed daily**.

...and the Real World



- In the operational **"real world"**, various real-time measurement software packages are available.
- These solutions cover detailed processes (e.g., within a refinery) on a single movement level, providing the raw
 measurement data which is then passed into the SAP Oil & Gas system via the SAP QCI. BCS ensures that only good
 data is passed to the SAP system, and that data is enriched (additional required data is calculated) for all relevant
 SAP Oil & Gas business processes.



Available Calculations

- There are three known SAP Petroleum liquid conversion products on the market, at the time of analysis:
 - **QuantityWare GmbH –** SAP certified ABAP solution BCS
 - Flow Cal Inc. C source integration "API C 2004"
 - Implico GmbH C Source integration "API C 1980" (OpenTas® QCM)
- Note: There are **no known comparable calculation solutions** for the Natural Gas, Hydrogen and LNG calculations provided by QuantityWare BCG for gaseous prodcuts.



Calculation Comparison - Method

- Using publicly available information from each of the supplier web sites, we have developed a set of comparisons between the petroleum calculation offerings.
- Comparison characteristics have been selected by QuantityWare, based on our experience of customer requirements.
- The comparison of these characteristics is displayed on the following slide.
